



**MEMORANDUM OF AGREEMENT
BETWEEN
FACULTY OF NURSING, KHON KAEN UNIVERSITY
AND**



FACULTY OF HEALTH SCIENCES, MUHAMMADIYAH UNIVERSITY OF SURABAYA

This Memorandum of Agreement (This MOA) is made and entered into by and between:

FACULTY OF HEALTH SCIENCES, MUHAMMADIYAH UNIVERSITY OF SURABAYA, as well-known faculty in Surabaya, with an office located at Sutorejo Street number 59, Surabaya, East Java, Indonesia, 60113, Telephone numbers: +62313811967; and

FACULTY OF NURSING, KHON KAEN UNIVERSITY, as well-known Faculty in Khon Kaen, with an office located at 123, Moo 16, Nai Mueang Sub-District, Mueang District, Khon Kaen, Thailand, 40002, Telephone numbers: +66 43 202 407

Based on MoU between Faculty of Health Sciences, Muhammadiyah University of Surabaya (FOHS-MUS) and Faculty of Nursing, Khon Kaen University (FON-KKU) both parties recognize the benefits strong international links. To this aim we propose the following agreement:

1. The purposes of this agreement are to develop academic and educational collaboration and to promote a joint relationship between the FON-KKU and FOHS-MUS.
2. Both institutions undertake to promote and develop cooperation in the following ways, on a basis of equality and reciprocity:
 - a. Exchange of teaching staff (Lecturers);
 - b. Exchange of researchers;
 - c. Exchange of students;
 - d. Conducting reciprocal lectures and seminars;
 - e. Conducting in research and the publication of its results;
 - f. Identifying other mutually agreed opportunities for collaboration.

3. To implement these forms of cooperation, representatives of our individual institute/faculty will be encouraged to consult with each other and to develop specific plans for collaboration in any or all of the ways outlined in agreement two above.
4. It is understood that the implementation of any of the types of cooperation stated in agreement above shall depend on our mutual availability of resources and financial support from our respective institutes as listed in ANNEX 1.
5. This agreement will come into effect on the date when the representatives of both parties sign the agreement and will remain valid for period of five years. The agreement may be extended by written consent after discussion with representatives of both parties. Such discussion needs to commence not later than six months before the termination of the agreement.
6. The agreement may be revised or modified within that period by mutual written consent. Similarly, the agreement may be terminated within the period by either party providing six months notice is given to the other.
7. The evaluation will be conducted by FOHS-MUS and FON-KKU after two years implementation of this MoA and changes mutually agreed in writing may be available to those which will adjust with the new collegial institution.

ANNEX 1 : Number of Participants

The number of exchanged students, lecturers and researchers can be arranged as follows:

- a. The maximum of 15 students will be exchanged between institutions for each year.
- b. The maximum of 5 lecturers will be exchanged between institutions for each year.
- c. The maximum of 2 researchers will be exchanged between institutions for each year.

However, the decision will be made together by the two institutes.

ANNEX 2 : Financial Arrangement

Both institutions agree to finance the academic exchange program based on the following arrangements:

- a. Visa, fiscal and plane ticket arrangements are reponsible by home institution.
- b. Both institutions agree to waive the tuition fee of the exchange students.
- c. Period of exchange is four months in maximum.
- d. Accomodation for students/lecturers/researchers who participate in the exchange program is facilitated by host institution.
- e. Accomodation and domestic transportation are provided by host institution with free of charge.
- f. Living expenses such as meals and telephone cost shall be responsible by home institution.
